
We are in receipt of your request dated May 5, 2021 in which you requested a time extension to the Vision Partnership Program (VPP) grant contract between the County, Birmingham, East Bradford, Kennett, Pennsbury, Thornbury, and Westtown Townships, and your planning consultant.

An addendum to the Vision Partnership Program Grant Contract has been approved, extending the timeline six months to January 31, 2022. In connection with the approved Vision Partnership Program Grant Contract between Birmingham Township (serving as the lead municipality), East Bradford Township, Kennett Township, Pennsbury Township, Thornbury Township, and Westtown Township, Brandywine Conservancy, and the County of Chester, and dated March 5, 2020, all parties accept the following changes as a contract addendum. This Contract Addendum specifically applies to the Brandywine Battlefield Heritage Interpretation Plan. Except as specified below, the general conditions, standard articles of agreement, grant amounts, and scope of work elements prescribed in the original contract shall continue to apply.

I. Contract Amendments:

The contract is being amended as follows subject to conditions set forth herein:

- A. The Contract Term is extended by six months to January 31, 2022.

II. Contract Addendum Conditions:

- A. The aforementioned adjustment of the contract term is subject to all Contract stipulations and covenants;
- B. The rights of the County of Chester are not prejudiced; and
