HISTORICAL COMMISSION

Harriet Tubman Scenic Byway

A presentation was made by John Haedrich and Mary Fahner- Short on the byway project and its relationship to the Historic nature of the Harriet Tubman trail. The Township had requested that the Historic Commission provide input as to a proposal to activate a scenic highway management plan in Kennett Township for the Harriet Tubman Scenic Byway.

<u>Spar Hill:</u> The task force assigned the Spar Hill Farm discussed finalizing a presentation to the Board depicting each of the twenty-four (24) structures on the property and a breakdown of costs associated with the demolition vs. stabilization costs. The importance of the structure and any KTHC recommendation will be highlighted.

PLANNING COMMISSION

<u>Bishop Nursing Home, Inc. – 1048 E. Baltimore Pike</u> Preliminary/Final Minor Subdivision Plan

The subdivision plan proposes a lot line revision between UPI #s 62-1-42 (1048 E. Baltimore Pike (6.236 +/-acres) and 230 Kennett Pike (1.8 +/- acres), located in the V-1 – Village District - Hamorton Zoning District. The purpose note on the plan states that the purpose of the plan is to subdivide the existing vacant parcel, containing approximately 6 acres, into two lots/parcels. Lot #1 is proposed to be conveyed to Longwood Gardens, Inc. Lot #2 is to be conveyed to the Lands of Lauren E. Strine & David E. Holt (UPI # 62-1-42.1) and become an integral part thereof. There are no proposed improvements on either lot/parcel with this plan submission. The existing Veterinary Center is currently serviced through public water and an on-site sewage disposal area.

<u>Estate of Enrico Avello Sr. – 552, 554, 556 Creek Road</u> <u>Final Minor Subdivision</u>

The Subdivision Plan proposes to reconfigure lot 2 for the existing dwelling and consolidating the remaining parcels into a single agricultural parcel. The project is located in the SA – Specialized Agriculture zoning district. Access to the site is currently provided through a 10-foot-wide private right of way via Creek Road. No new building lots are being created and no construction or earth-moving activities are being proposed. No new sewage or water supply is proposed.

Kennett Township Zoning Code Update: The Planning Commission is continuing final review of the update.
